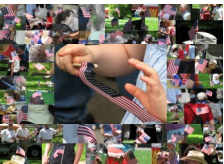


The Honour Project provided 58 flights in 2012, 58 in 2013, and 68 in 2014.

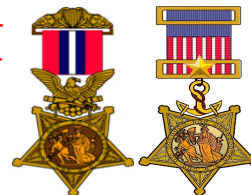
FLAG DAY June 14th

2nd Vice Commanders Message—regarding Medal of Honor continued.

Many Americans distinguished themselves in Civil War battles but were not eligible for the Medal of Honor. These men fought for the Confederacy. But while Rebel soldiers could not receive the medal, they were cited for the highest award of the Confederate States of America and listed on its Roll of Honor, the closest the South came to its own Medal of Honor.

Like their counterparts and senators favored the award for the fall of 1862 was sent to

terparts in Washington, Confederate representatives in Richmond creation of an individual valor. In such a measure chambers and President Jefferson Davis, who signed it into law on October 13. In

Language similar to the Union resolution of the past year, the Confederate bill directed "That the President be, and he is hereby authorized to bestow medals, with proper devices, continued on page 2.

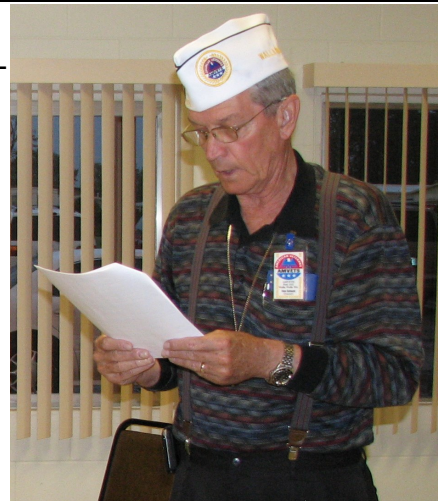
Post Commander's Message

...upon such officers of the armies of Confederate States as shall be conspicuous for courage and good conduct on the field of battle, and also to confer a badge of distinction upon one private or non-commissioned officer of each company after every signal victory it shall have assisted to achieve."

The Law made no provision for a medal for the Confederate navy.

In a radical departure from the tradition exemplified by the Union awards, the act mandated that enlisted would be selected for the medals by majority vote of the men themselves. Such a democratic method of bestowing decorations was virtually unknown. This was more than a typical campaign; only a select few from each battle would be recognized by their peers.

Delays in the creation of the medal, however, threatened to dilute the Confederate award's impact on the ranks of southern soldiers. In October 1863 almost one full year after the original act, the Adjutant and Inspector General's Office of the Confederacy published an order acknowledging "difficulties in procuring the medals and badges of distinction" promised earlier. "To avoid postponing the grateful recognition of (the men's) valor until it can be made in the enduring form provided by the act, " the order established a "Roll of Honor," with the name of each man cited, to be read before every regiment and published in at least one newspaper in every Confederate State. Two Rolls of Honor distributed in 1864 listed a man from each company from several battles. In the engagement at Seven Pines, Virginia, in June 1862, for example, nine men from ...continued on Page 4...

...the 8th Infantry Regiment were cited, although no mention was made of their particular actions. The details of the elections to the roll are sparse, but the diary of a Confederate captain provides an example of a company election for the roll. Robert Emory Park of 12th Alabama Regiment wrote the following entry for May 19 and 20, 1863 when his regiment was encamped at Macon, Georgia:

The election held to decide who of the company should wear the "Badge of Honor" for gallantry at Chancellorsville resulted in twelve votes each for Sergeant Wright and Private Chapell. In drawing [as for lots or straws], the latter won, and his name was sent to General Lee.

The Confederate medals were never struck. Nor do

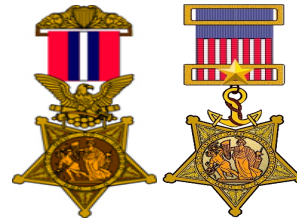
Per the Post meeting held March 18, 2015 the duties of select elected officer positions, as noted in our Bylaws will be posted in the Newsletter until all have been posted at least once.

Section 5. The Finance Officer shall:

- a. Serve as treasurer of the Post.
- b. Be responsible for receiving membership dues, all monies due the Post, banking, disbursement of monies and accounting for all Post funds.
- c. Sign, with one other officer, usually the Commander, all Post checks as authorized by the Executive Committee.

- e. Serve as the Executive Committee member of the Finance Committee to develop the Annual Budget and Annual Audit of the financial records.
- f. Utilize an efficient accounting system to record all Post income and expenditures.
- g. Prepare monthly and annual financial reports to be presented to the Executive Committee and at Post Meetings
- h. Assist the Commander by serving as the Executive Committee Member of the Post Finance Committee.
- i. Fulfill other duties as requested by the Commander and outlined by the National Constitution and Bylaws.

any proposed designs survive. In May 1864 a Tennessee representative stood in the Confederate House chamber to ask what progress was being made on the medals and if any further legislation was needed to hasten their creation. There, any mention of the awards in the official records ends. The tide of the conflict had turned against the South, and within

a year the Confederacy would be crushed, its medal forgotten, and its heroes never to be recognized by a badge of honor.

Section 6. The Judge Advocate shall:

- a. Assist the Commander by serving as the Executive Committee member of the Constitution and Bylaws Committee.

- d. Be responsible for drafting Resolutions for submission to the Department Judge Advocate for further processing with the National Headquarters.
- e. Provide the Executive Committee and Post members with a [mal report on the action taken with respect to all proposed amendments and resolutions that have been submitted to the Department Judge Advocate.
- f. Fulfill other duties as requested by the Post Commander and as outlined by the Department and National Constitutions and Bylaws.

To be eligible for membership, you must have served in the U.S. Armed Forces, including the National Guard and Reserves, anytime after Sept. 15, 1940. Additionally, unless still serving, your discharge must have been under honorable conditions. If you served as an American citizen in the armed forces of an allied nation, under honorable conditions, between Sept. 15, 1940 and May 8, 1975, you are also eligible, as are wartime members of the Merchant Marine. Proof of eligibility can be the form of a DD-214, an honorable discharge certificate or other appropriate document.
